FOREWORD

Year 2020, was the most challenging year for the whole world due to Covid-19 Pandemic. For PIFD these were unprecedented times but with resilience, discipline and hard work of faculty, staff and students we managed to make the best out of the appalling situation faced not only by Pakistan but the whole world.

To cope with this unprecedented situation so that students' learning outcomes were not compromised PIFD adopted Hybrid/ Blended Model of teaching. Purchased and installed teaching softwares approved by HEC such as Microsoft Teams, Zoom & Google Classroom and also conducted faculty trainings. All online courses with course material, presentations and videos were approved by Online Academic Council before the commencement of online classes.

Every year PIFD sends its faculty and students to different institutions around the world but as traveling was not safe in 2020, the students attended webinars and faculty had the opportunity to attend national and international online trainings, workshops, exhibitions and conferences including World Marketing Summit. Series of Webinars were conducted to bring Fashion Designers. Retailers, journalist, PR personnel, bloggers, entrepreneurs and industry stakeholders from Pakistan and abroad with the aim of facilitating students learning and healthy educational interaction during period of campus closure.

This year 192 students graduated from seven undergraduate programmes namely, Fashion Design, Fashion Marketing and Merchandising, Textile Design, Leather Accessories and Footwear, Jewellery Design and Gemological Sciences. Furniture Design and Manufacture, Ceramic and Glass Design and students obtained their M.Phii. Degrees in Art and Design Education. Online and on Campus Juries and Thesis Exhibition were held to keep students safe without compromising on Academic Standards.

In June 2020, admissions were held and after test and interview 450 students were selected for enrollment in Foundation Year.

The 3th Convocation of PIFD was held on 17th November, 2020 presided by the Honorable President of Pakistan/ Chancellor PIFD.

PIFD International Office (PIO) worked on developing sustainable relations with other International Institutions and Organizations. Through Erasmus Mundus Programme of European Union trainings were held for the Project titled 'B International'.

The growth of PIFD and its present stature is due to the support of the Government and the Senate Members of PIFD who strongly believe in merit. It goes without saying that the industrial Linkages are the key for the development of new programmes and employment of PIFD graduates. I hope we continue to strive for the bright future of our students in these challenging times.




ACADEMIC ACTIVITIES

QUALITY ENHANCEMENT CELL (QEC)

Quality aims to monitor the effectiveness of the academic activities for sustainable growth of institute by achieving its mission, vision & objectives. Quality Assurance in Higher Education is a global challenge which demands enhancing the Quality of Higher Education on viable and sustainable basis.

Pakistan Institute of Fashion and Design (PIFD) provides a platform where students of different regions of Pakistan interact with each other. Along with studies they learn and exchange culture, values, resources and potential within country, which develop harmony in youth and contributes to economic and cultural growth.

During year 2020, Higher Education remained uncertain all over the world due to the pandemic situation caused by the Coronavirus (COVID-19). Universities throughout the world have been transformed rapidly to online teaching that also forced to adopt particular resources at once for virtual setup. Higher Education Commission (HEC), Pakistan took the charge and collaborated with National and International agencies to lay down strategies for pandemic situation and provided facilitation to Universities and Institutions to initiate online learning so that precious time of students can be saved. HEC issued guidelines for HEIs, faculty, staff, teaching and online readiness concerning COVID-19. The Honorable Vice Chancellor exhibited tremendous patronage and reacted strategically in close liaison with HEC and took pandemic as a chance for PIFD to turn a new leaf in area of online Fashion and Design learning.

The Quality of Education during the pandemic was the biggest challenge particularly for institutions that do not have already established setup for online teaching. Lectures and discussions turned on virtually on Zoom, Google Classroom and Microsoft Teams, similarly assessments also went digital. The role of Quality Enhancement Cell (QEC) remained to focus on Quality Assurance aspect of online education in-line with Quality Assurance polices of HEC.

PROGRESS

It was a challenge to ensure the quality of teaching and learning for online classes through different Learning Management Systems (LMS). In accordance with the HEC guidelines online readiness model policy was introduced covering University, Course, Faculty, Technology, Library, Student, Evaluation and Laboratory Readiness as well as policy for reopening of the universities/institutes.

At first, Online Academic Council (OAC) was formulated at PIFD chaired by the Vice Chancellor to ensure the quality of online education. PIFD adopted hybrid model of teaching and operationalized through Microsoft Teams and Zoom for online classes.

Throughout the pandemic year 2020, 44 courses of different degree programmes approved by the OAC were offered online accordingly.

Following elements were uploaded to LMS and conveyed to the students:

- 1. Introduction to the course
- 2. Learning Objectives
- 3. Textbooks to be used for the course
- 4. Description of the system of evaluation (exams, etc.)
- Detailed lesson plans for each remaining lecture
- 6. Key dates, time and venue of meetings

To implement Faculty Readiness, 68 faculty members were trained on LMS by Certified PIFD Resource Person to ensure their Technology Readiness. Afterwards, each faculty member presented his/her courses before OAC, for its approval.

PIFD also acquired demographical information related to the students and IT facilities available to them at their residences which includes type of internet, machine and mobile networks. Students were given logins on LMS and trained to attend their classes smoothly.


Grievance Committee was also constituted by OAC to address the complaints of students regarding online teaching. A Complaint log was also maintained by IT department to address IT issues faced by the faculty and students during online classes.

Assessment and Examination Policy for online classes during Covid 19 was implemented on the recommendations of OAC. PIFD also has a valid subscription of Digital Library through HEC-PERN. All required material (e-books / research articles) of the courses was made available to the faculty and students by the Library, through Virtual Private Network (VPN).

SURVEYS

Surveys for Course Evaluation of online classes were carried out from students of each department to get their feedback. The Students were asked about the online course contents, learning environment, teaching methodology and the quality of delivery of lectures. Feedback/Suggestions by the students for improvement in online lectures were compiled by QEC and reviewed by the Course Coordinator of respective departments. Evaluation Reports were generated through MS. Excel and SPSS software. Out of 5, the average score of surveys for each department is hereby shown graphically; as follows:

CONSTRUCTION OF PURPOSE BUILT HOSTEL FOR FEMALE STUDENTS

PIFD has been allotted a piece of land measuring area 11 kanals, 9-marlas and 146 Sq. ft. for the construction of its purpose-built Hostel buildings. Accordingly, the Planning and Development Department of PIFD developed the proposal for construction of female hostel for 160 students as phase-1 and submitted its PC-II to the respective Development Wing of Ministry of Federal Education and Professional Training, Islamabad. Departmental Development Working Party (DDWP) in its meeting held on 9th March, 2020 approved the PC-II of this female hostel project with the cost of Rs. 05 Million for its design / drawings work and development of PC-1. This project was also included in PSDP-2020-21 and funded to complete the project activities by June 2021.


FINANCIAL FOR FY 2019-20 AT A GLANCE

The main source of self-generated income for PIFD is the fee charged from the students. During the reporting period, an amount of Rs. 280.401 million was collected as self-generated income.

STRENGTHENING TECHNOLOGICAL INFRASTRUCTURE

INTRODUCTION

Information technology is the backbone of the any academic institute. As a matter of policy, Pakistan Institute of Fashion and Design (PIFD) strives for the best and latest practice implementation of Information Communication Technology (ICT). Information Technology Department is playing a vital role to uplift the quality of services related to ICT.

IT INFRASTRUCTURE OF PIFD

PIFD IT infrastructure consists of more than 700 network nodes which are utilized in the Computer Labs, Offices, Auditorium, Lectures Halls, Library, Conference Room etc.

DATA CENTER

PIFD had established state of the art tier-2 Data Center for its campus, IBM blade sever technology is deployed at server side, whereas CISCO solution is deployed for the network infrastructure and Wi-Fi services.

COMPUTER LABS

Computer labs are majorly operated under two different concepts; general purpose and special propose i.e. CAD/ CAM. Currently PIFD has six functional computer labs, being used by Foundation Year Studies, Fashion Design, Textile Design, Fashion Marketing and Merchandising, Gems and Jewelry Design, Leather Accessories and Footwear Design, furniture Design and Manufacture and Ceramic and Glass Design.

ONLINE CLASSES

Under the guidance of PIFD administration, IT department has got subscription of "MS Teams" Learning Management System (LMS) by Microsoft for online classes since March 2020 during pandemic Covid-19. Furthermore in Google Classroom and Zoom are also available for online classes and virtual meetings. The department is providing ongoing support to faculty and student during their online classes.

SYSTEM INFRASTRUCTURE MANAGEMENT

Pakistan Institute of Fashion and Design (PIFD) has planned to deploy the E-Office (Suite) to switch over from physical system to paperless system through the automation of following identified common business processes:

- Internal Communications & Movement of Files (IC)
- Human Resource Management System (HR)
- Inventory & Procurement Management System
- Project Management System (PMS)
- Finance, Planning & Budgeting
- Internal Portal

Intranet service by National Telecommunication Corporation are operational and PIFD personnel get online training over test server of E-Office. The manual system of official Correspondence will switch over to paper less system by March 2021.

PRIME MINISTER PERFORMANCE DELIVERY UNIT (PMDU)

The department is providing technical support to the administration for effective implementation of Prime Minister's office directives. Composite Tasking ePortal and PMDU dashboard is managed by IT department for dealing the tasks assigned by PM office to enhance the level of services and handling public complaints.

ONLINE ADMISSIONS

Due to Covid-19, Online Admission Portal was published first time to carry out the process of admissions for the session 2020 – 24. Total 452 student got admission in undergraduate programme.

NETWORK INFRASTRUCTURE MANAGEMENT

IT Department is continuously working to secure the Network Infrastructure through implementation of following measures:

NETWORK SECURITY

Network traffic is protected behind the Firewall to protect against illegal network traffic and to avoid unauthorized access of Network resources. To improve the quality of Network Services; Implementation of Bandwidth Management, VLANs, Traffic Storm Control, IP Source Guard, DHCP Snooping & Port Security are being implemented on different sites within the institute.

ACTIVE NETWORK INFRASTRUCTURE MONITORING

Centralized monitoring / control of Network Infrastructure is carried out for better optimization of network and to improve the quality of services.

NETWORK LOOPS PREVENTION

Network loops were identified in existing Network causing service interruption in Network services. Preventive measures were taken against physical and logical loops for provisioning of smooth network services.

CENTRALIZED MANAGEMENT OF NETWORK

Centralized Management and Access of Data Center System & Network devices and access layer CISCO & PTCL devices.

NETWORK MONITORING

Active network infrastructure monitoring using open source tools and bandwidth management using rate limiting.

BACKUP INTERNET SERVICE

A PTCL link has been integrated with existing Network infrastructure as backup for continues provision of internet services at campus along with PERN services.

NETWORK TRAFFIC PRIORITIZATION

Network Traffic prioritization has been implemented for Learning Management System (Microsoft Teams) for smooth online classes.

SYSTEM INFRASTRUCTURE MANAGEMENT VPN Server

To facilitate the postgraduate students, researchers and PIFD faculty, IT Department has established Virtual Private Network (VPN) Server to provide access over three major resources EBSCO host, HEC Digital Library, WGSN 24/7 remotely. This facility is optimized upon the request of MPhil Art & Design Education Department which was previously not available.

Antivirus Malware Protection

Previously virus attacks and Malware protection was not available in the institute causing frequently crashing of operating system & software, on computer systems being used in offices and computer labs. IT Department resolved the issue by implementing Malware and Virus protection.

Windows Update Services

Update Server is configured in the Data Center. Updates are being installed on the computer systems installed in computer labs through Update Server to prevent them from open world threats.

Social Media Restriction

Social media restriction is being implemented on LAN and WIFI as per management policy

Video Conference

Video Conference facility is available at PIFD to participate in online meetings, seminars, workshops, lectures, etc. IT department is organizing and managing this facility.
